D. WVIA Financial Protocol

The Board will hear three recommendations from the Executive Committee:

- 1) to amend Financial Protocol Item #8 from "Any one Board Officer or the Executive Director may sign checks up to \$1,500. Checks over \$1,500 require two signatures from any Board Officers or the Executive Director" to "Any one member of the Executive Committee or the Executive Director may sign checks up to \$2,500 or any rent checks payable through a Board-approved lease agreement. Checks over \$2,500 require two signatures from any Executive Committee member or the Executive Director."
- 2) to eliminate Financial Protocol #12 which reads, "Credit cards and debit cards will not be issued."
- 3) to amend Financial Protocol Item #15 from "WVIA contracts exceeding \$5,000 require the procurement of at least three competitive bids. Large contracts will be reviewed by the Board prior to execution" to "WVIA contracts exceeding \$10,000 require the procurement of at least three competitive bids. Large contracts will be reviewed by the Board prior to execution."

After discussion, Kevin Crummy made the motion, seconded by Jessica Dabney, to approve the three Executive Committee recommendations. All in favor. The Board asked the Executive Committee to agendize at a future meeting the establishment of protocols for WVIA credit card oversight.

E. Sepulveda Transit Corridor Project

The Board will hear a presentation from Metro and also UCLA Transportation regarding Metro's Sepulveda Transit Corridor

After discussion, Jessica Dabney made the motion, seconded by Josh Trifunovic, to support the proposed Sepulveda Transit Corridor Project with underground transit lines, a stop at the UCLA campus, and a connection to the Metro Purple Line. All in favor.
